REGIONAL CENTER REFERRAL CRITERIA

- 1. **Early Start Program Eligibility** 0-36 mo, needs documented developmental delay, high risk for developmental delay, or at risk of developmental delay due to two or more biomedical risk factors
- 2. **Lanterman Program Eligibility** >3yo, developmental disability caused by (Intellectual Disability, Cerebral Palsy, epilepsy, autism, fifth category), disability originated before 18yo, indefinite prognosis, substantial disability, and not solely psychiatric, learning or physical.

NEW P4V HEDIS METRICS TFL-CH AND DEV TFL-CH – TOPICAL FLUORIDE FOR CHILDREN

Percentage of enrolled children 1-20 yo who received at least two topical fluoride applications as dental or oral health services within the measurement year.

- CPT Code 99188 (application of topical fluoride varnish by a physician or other qualified health care professional); reimbursable for children <6yo per Medi-Cal rules, but;
- CHA will reimburse for this code for all children (up to twice a year) \$23.22 or,
- CHA will reimburse reporting fluoride applications at the dentist's offices (up to twice a year) \$10.00

DEV - DEVELOPMENTAL SCREENING IN THE FIRST THREE YEARS OF LIFE

For Members 1-3 years of age, the percentage of children screened for risk of developmental, behavioral, and social delays using a standardized screening tool between 0 and less than 1 years old, between 1 and 2 years of age, and between 2-3 years of age.

- CPT Code 96110 (Developmental screening)
- Reimbursed \$59.00 from Prop 56
- Acceptable screening tools:ASQ-3, PEDS, SWYC
- MCHAT is not an acceptable tool for this metric.
